## A. ART (Rosenstreich, Wright)

a. M/S (Whetzel/Cechin) to approve the Textiles/Clothing Construction certificate. Dingman-Katz requested for this proposal to be tabled as she is working on edits to the program. M/S/C (Whetzel/Cechin) to table the program modification.

### B. ATH (Gordon)

## 1. ATH 206A - Theory and Analysis of Basketball IIA

a. M/S/C (Cechin/Velazquez-Zvierkova) to approve ATH 206A. Cechin questioned if SLO #2 was assessable as written. Suggested changing qualities to skills. Cechin pointed out that practice films were mentioned in SLO #1 but not referred to in the outline. Gordon will review and revise.

## 2. ATH 221 - Theory and Analysis of Softball I

a. M/S/C (Velazquez-Zvierkova/Cechin) to approve ATH 221. Gordon explained that this course is a theory course for both players and coaches. Cechin suggested adding more content to the outline regarding coaching philosophy since it is referenced in the SLOs.

## 3. ATH 227 - Theory and Analysis of Soccer I

a. M/S (Whetzel/Cechin) to approve ATH 227. Objectives #1 and #2 are the same as SLO #1. Gordon was asked to review and revise. M/S/C (Whetzel/Cechin) to table ATH 227.

# 4. ATH 240 - Intercollegiate Volleyball

a. M/S/C (Velazquez-Zvierkova/Terrill) to approve ATH 240. Aguirre found SLO #2 confusing. After reviewing, 'their' was removed. Osea asked about the lab hours of the course and why it is 10 hours for three units instead of nine hours. Osea added that with the new standardized attendance accounting method the college could lose money, and student athletes are putting in more hours than they are being credited for. Montes agreed that student athletes are putting in more hours than they are getting credit for but also acknowledged that student athletes are not paying for that extra hour. Montes continued to explain that allowing extra hours is a permissible practice and is also done in chemistry, biology, and physics courses. Athletic Director Gordon added that student athletes want to put in extra time. Gordon continued to explain that student athletes are allowed 175 hours of practice and conditioning per semester and our campus already has reduced time with offering only 170 hours, and to stay competitive, it is important that our student athletes have that extra time. Osea informed the committee that the Chancellor's Office will be issuing guidance on fractional hours in the near future, and it is something we should consider. Montes explained to the committee how FTES are currently calculated and how they will be calculated with the new standardized attendance accounting method. Montes also added that it is not in the purview of the Curriculum Committee to make fiscal decisions.

#### C. COMM (Gehrman)

# 1. COMM C1000 - Introduction to Public Speaking

a. M/S/C (Velazquez-Zvierkova/Terrill) to approve the course proposal. Terrill asked about SLO #3 and if it is measurable. Gehrman explained how "active" listening skills are demonstrated. Whetzel asked about the CCN template and if it helpful for instructors and did it provide enough detail. Gehrman replied that the template mostly reflected what is covered in the course and will have discussions with faculty for supplementation.

#### D. CSC (Pai)

## 1. CSC 221 - Programming and Algorithms I

a. M/S/C (Terrill/Cechin) to approve CSC 221. Terrill asked why the lab hours were originally removed from the course. Pai explained that the lab component of the course was removed to reduce the units of the course so it can be added to the Computer Science ADT. Now that the GE units will be lowered with the upcoming Cal-GETC pattern, the lab hours can be added back into the course.

## 2. CSC 222 - Programming and Algorithms II

a. M/S/C (Whetzel/Velazquez-Zvierkova) to approve CSC 222.

## 3. CSC 150 – Python Programming for Cybersecurity

a. First reading for CSC 150. Pai explained that this course is primarily for the cybersecurity degree as python is better suited than another course in the program.

Aguirre suggested adding an objective related to ethics since it appears in the SLOs and outline.

a. First reading for ART 142. Wright explained that he is hoping this course will be approved for Cal-GETC. Osea asked if Wright would be open to reducing the lab hours to 1.5 hours as the ratio of lab hours to theory hours can affect GE. Wright prefers to keep the lab at 2 hours. Aguirre suggested pulling the lab component out of the outline and leaving just the lecture portion since there is already a lab outline. Whetzel suggested adding more objectives to reflect the theory portion of the course. Velazquez-Zvierkova suggested reviewing and revising SLOs with measurable verbs.
