Students who have previously used GI Bill Benefits

- ➤ If you have used your GI Bill benefits before at a different school, complete and submit a Request for Change of Program or Place of Training, VA Form 22-1995 to the VA. For VA dependents using Chapter 35 it is VA Form 22-5495. These forms can be accessed electronically for electronic submission at http://vabenefits.vba.va.gov/vonapp/main.asp. Bring a copy to the Mendocino College Admissions & Records Office and schedule a meeting with the School Certifying Official after completing the matriculation steps (see reverse side).
- ➤ If you have previously used your GI Bill Benefits at Mendocino College and plan on continuing to use your benefits you must let the School Certifying Official know in writing each semester that you wish to continue using your benefits in order to certify your actual enrollment period to the VA.
