

Mendocino College PTA Program Application Instructions

Thank you for your interest in applying to the Mendocino College PTA Program. Program applications will be accepted each year between the dates of August 15 and October 15. A computer generated lottery system will be used to select 24 students for acceptance from the qualified applicants. Applicants will be notified of lottery results in November.

Qualified applicants will meet the following criteria: 1) Admission to Mendocino College 2) Completion of PTA Program Application 3) Completion (or progress towards completion) of the four pre-requisite courses with a grade of "C" or better 4) Submission of official college transcripts verifying successful completion (or progress towards completion) of pre-requisite coursework.

Please follow the following steps to complete the application process.

Step 1

Apply to Mendocino College either in person at the registrar's office or online. If applying online, use the following link and follow the prompts: <https://www.mendocino.edu/admissions>.

Step 2

Complete the application that is located on the next page and submit electronically or by mail to PTA Program Director, Sara Bogner. Her email address is sbogner@mendocino.edu and mailing address is 1000 Hensley Creek Road, Ukiah, CA 95482.

Step 3

Submit official transcripts to verify completion of pre-requisite coursework to PTA Program Director, Sara Bogner. Transcripts can be sent electronically directly from the institution or via mail. After Acceptance and Prior to Enrollment:

1. CPR for Healthcare Provider - You must present a valid CPR card for Healthcare Provider offered through the American Heart Association prior to the beginning of the program. Card must be valid throughout the duration of the program.
2. Health Clearance - Applicants must present evidence of physical fitness and ability to perform tasks required of a physical therapist assistant. Physical exam and immunization records must be cleared and verified after acceptance into the program. Technical Standards/Essential Functions are provided as a link on the PTA web page. Students are expected to be able to perform all Technical Standards/Essential Functions throughout the program.
3. Criminal Background Check - Clinical placements are a mandatory component of the curriculum and will require clearance of a criminal background check. Students who do not clear agency requirements are not eligible for clinical placement and will, consequently, be ineligible to continue in the program.
4. Drug Screen - A drug screen is required prior to beginning the program and may be required prior to each clinical education experience depending upon the site requirements.
5. If admitted to the program, failure to present the required documents described above by the deadline may result in reversal of acceptance or dismissal from the program.

Accreditation Statement

Mendocino College is seeking accreditation of a new physical therapist assistant education program from CAPTE. The program is planning to submit an Application for Candidacy, which is the formal application required in the pre-accreditation stage, on June 1, 2019. Submission of this document does not assure that the program will be granted Candidate for Accreditation status. Achievement of Candidate for Accreditation status is required prior to implementation of the program; therefore, no students may be enrolled in the program courses until Candidate for Accreditation status has been achieved. Further, though achievement of Candidate for Accreditation status signifies satisfactory progress toward accreditation, it does not assure that the program will be granted accreditation.

Nondiscrimination Statement
